Let it be known that I, James Warren "Flaming Eagle" Mooney of Seminole American Native Ancestry testify, that my Seminole American Native Ancestry grandparents, from my biological father, dedicated me to be an American Native Medicine Man in an infant dedicatory Amachekee Ceremony when I was four years of age<sup>1</sup>; I have been blessed to carry and make American Native Indigenous Sacred Prayer Pipes by a Seminole Tribal Chief Little Dove and her Tribal Council<sup>2</sup>; I have been blessed to administer Huichole Peyote Spiritual Practices by Huichole Mara'akame Guadalupe "Lupe" Silva de la Cruz<sup>3</sup>; I have been blessed to administer the Native American Church Sacrament "Peyote" and to formulate a Branch of the Native American Church Rosebud Reservation of South Dakota by President Leslie Fool Bull of Lakota Sioux Ancestry<sup>4</sup>; and that I am a Co-Founder of the Oklevueha Native American Church<sup>5</sup>.

With the spiritual authority invested in me through these, United States Federal Government validation, dedication and blessings; I bless **Phillip "Cloudpiler" Landis** to honor the before mentioned American Native Spiritual Leaders "edicts" to share Indigenous American Native Sacred Ceremonies with all sincere intentioned human beings through the **Oklevueha Native American Church of Sanpete**.

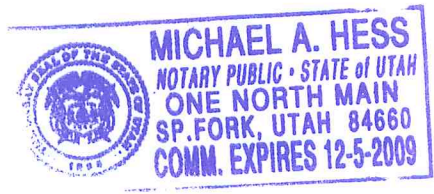

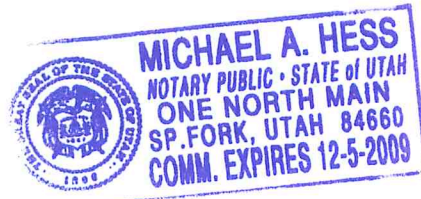

## DECLARATION

And, as an American Native Indigenous 'earth' based and 'healing' religion that is known as Oklevueha Native American Church (Native American Church and / or NAC)<sup>IV</sup> I, James Warren "Flaming Eagle" Mooney, solemnly swear and;
